Our policy put in place to ensure the accessibility of beneficiaries with disabilities

1- Training of the "disability contact" in welcoming disabled people: Florence de Cazanove

- Person in charge of relations with customers and trainees in a situation of handicap: Florence de Cazanove.
- Specific "Disability" file: several documents (pdf) raising awareness of the 5 major types of disability (Agefiph, Ministerial Delegation for Accessibility): hearing, mental, motor, psychic, visual.
- Information and awareness videos on Disability

2- Understanding the specific needs of PWD (Persons with Disabilities)

In the case of intra- or inter-company training programmes, specific needs are identified when contacting the customer and recorded on the document "registration form".

The offer proposed to the client includes the compensation terms. In the impossibility to answer them, we refer the client to our specialized partners.

3- Our ethics and professional conduct regarding PWD

- We are committed to welcoming trainees with disabilities, or to guide if our training was not able to meet their specific needs.
- We undertake not to ask them the origin of their disability, nor the name of their disabling illness (this is medical confidentiality), but what they need.

4- Adaptation of training premises (if PMR type disability) (Person of Reduced Mobility)

- No premises rented to date, because the training takes place either internally at the customers, either intra or inter 100% remotely.
- Just in case, the "PSH trainee monitoring sheet" contains a checklist on the premises to be checked.
- Possibility of using premises accessible to PRMs

5- Adaptation of educational materials

- Our training materials are available in different formats: paper, USB key, recording... in order to be able to adapt them in the event of visual handicap, DYS,... (disorder of written language)
- Our media favors airy texts written in characters larger than size 14, in order to to facilitate reading for people with visual disabilities, DYS

6- Adaptation of educational arrangements

- When a person with a disability is registered for training, our representative Handicap is called upon to implement, as soon as possible, a cross-reflection on the situation, possibly involving other actors or specialists, indicated on our list of partners, to collectively design the arrangements useful for training courses.
- Thus, we take into account and implement the necessary adaptations in order to meet the person's compensation needs (pedagogy, materials, means techniques, humans...). The manager helps implement adaptations and is available as much as needed to respond to possible difficulties on the time of training.
- If the necessary adaptations to reception are not possible to implement (e.g.: technology impossible to mobilize within the framework of the service or in the allotted time), we help the beneficiary to reorient towards other training modalities, or other solutions.
